OFFICIAL RULES

- RULES:** the following rules for this tournament will be used. These rules will be interpreted solely by the Tournament Officials, and all decisions are final. Violations of Department of Conservation or State Water Patrol regulations shall be reason for disqualification. Failure to read these rules is no excuse for violating them.
- ELIGIBILITY:** All individuals, 18 years of age or older, with paid entry fee. Individuals under 18 years of age must be accompanied by parent or guardian. All participants must fish with a partner.
- ENTRY FEE:** \$120.00 per boat which includes the \$10 Big Bass Pool. The Big Bass Pool will be paid out at 100% to the team with the largest Bass. Entries will be accepted at the Dave Mungenast Marina on the day of the tournament until 7:30 am.
- HEADQUARTERS, TIME & DATE:** The Dave Mungenast Marina, Lake of the Ozarks. Fishing time is 8:00 am to 4:00 pm, November 28, 2009, December 26, 2009, January 30, 2010, February 27, 2010, March 27, 2010 and April 24, 2010. Public Beach 2 access should be used by all participants.
- LIVE-WELL CHECKS:** Live-well checks will be conducted at take-off. All entries must participate in live-well checks.
- DEPARTURE:** Will be in sequence in which entry fees are received. All boats will be released from the Dave Mungenast Marina.
- TACKLE & EQUIPMENT:** Only artificial baits or lures may be used. Pork style baits are allowed. No trolling allowed. All bass must be caught on rod and reel during tournament hours from a boat in a sporting manner.
- BOATS & EQUIPMENT:** Any boat 14 feet or longer will be accepted if powered by an engine of 10 horsepower or more. Boats must be equipped with functional aerated live-well. Boats may not be trailered during tournament hours. Boats may not have motors which exceed the horsepower rating or BIA rating placed on boat. All Missouri Water Patrol laws and regulations shall apply.
- SAFETY & SPORTSMANSHIP:** Safe boating and fishing practices must be observed at all times. Life jackets and ignition kill switches must be worn at any time the big motor is running. For safety reason no boater will be allowed to fish alone. Unsportsmanlike conduct will not be tolerated and will be grounds for disqualification. All Missouri Department of Conservations laws and regulations shall apply. No alcoholic beverages, stimulants or depressants are allowed to be used during tournament hours.
- PERMITTED FISHING LOCATIONS:** Anywhere on the lake, except within 50 yards of another contestant's boat, tied or at anchor with trolling motor up, or inside the no-wake buoy of the Dave Mungenast Marina.
- SCORING:** Largemouth Bass, Kentucky Bass, and Smallmouth Bass will be counted. Total stringer weight per team will determine place. Any bass under 15 inches presented for weigh-in will cause two pounds to be subtracted from total stringer weight, plus the loss of the short fish. Any bass dead when presented for weigh-in (as determined by Tournament Officials) shall result in .25lb., per dead fish to be subtracted from the total stringer weight. Five (5) fish per boat may be weighed in. Any frozen, iced or mangled fish presented for weigh-in will result in immediate disqualification.
- PROTESTS:** Protest must be submitted in writing and signed within 15 minutes of the conclusion of final weigh-in. The decision of the tournament officials will be final.
- TRUTH VERIFICATION:** By their signature on this entry form and/or participation in this tournament, each contestant agrees to submit to a polygraph test. ANYONE FAILING TO PASS WILL BE DISQUALIFIED AND ANYONE REFUSING TO TAKE A TEST WILL BE DISQUALIFIED.
- TIES:** Ties will be broken by the earliest starting position.
- CHECK-IN LATE PENALTY:** One (1) pound per minute, up to 10 minutes. After 10 minutes, team will be disqualified. NO EXCUSES. All participants are requested to check-in, regardless if weighing fish or not.
- TOURNAMENT CANCELLATION:** If tournament is cancelled due to reason of safety, etc., the entry fee will be returned. No refunds will be made for any other reason unless authorized by Tournament Officials.
